In the event of receiving a Permit, the applicant agrees to conform to all the conditions set by the Mt Buller Mt Stirling Resort Management's Dog Policy. A breach of these conditions may lead to a fine being imposed and in the case of a severe breach, cancellation of the Permit. In the case of a Permit being cancelled, there is no reinstatement of the permit in future, and the maximum penalty of bringing a dog into the Resort without a Permit can incur a penalty of 20 units.

It is the applicant's responsibility to ensure all permit conditions are adhered to, regardless of who may be in control of the dog at any given time.

Evidence must be provided for EACH of the 4 criteria outlined below

Criteria 1 - Fee

\$150 annual fee (please wait for approval)

Criteria 2 - Mt Buller Residency

2 (a) - Property Owners (please go to 2 (b) if you do not own your property)

Evidence of property ownership (e.g your name and property details from lease or sub-lease).

2 (b) - Year-round and seasonal residents (please go on to Criteria 3 if you own your property)

13 week consecutive minimum rental contract.

Criteria 3 - Supporting documents supplied by Body Corporate Apartment owners

If you are renting the apartment, written consent from the apartment owner and;

If your property is controlled or administered by a body corporate, supporting documentation from the body corporate permitting your dog onto the site;

Written confirmation of the unanimous consent of all apartment owners on the site.

Criteria 4 - Dog Registration Details

Provide current details of your dog's registration and where, outside Mt Buller Alpine Resort (a letter from your Vet stating dog's name, sex, breed and if it is de-sexed will suffice).

This permit application is for an individual dog, not the owner.

Completion of the form DOES NOT GUARANTEE permit approval.
