## **GENERAL CONDITIONS**

### 1. FEES

- 1.1 Fees for the 2017 Tranistionist Weekend program include tuition for 80 hours of supervised coaching (16 days as specified in item1.2, for 5 hours per day). These hours may include indoor training and activities as specified by the coaches or supervisors.
- 1.2 Dates coaching will be provided:
  - Weekends: 23<sup>rd</sup> & 24<sup>th</sup> July, 29<sup>th</sup> & 30<sup>th</sup> July, 5<sup>th</sup> & 6<sup>th</sup> August, 12<sup>th</sup> & 13<sup>th</sup> August, 19<sup>th</sup> & 20<sup>th</sup> August, 26<sup>th</sup> & 27<sup>th</sup> August, 2<sup>nd</sup> & 3<sup>rd</sup> September, 9<sup>th</sup> & 10<sup>th</sup> September 2017.
- 1.3 No discounts, credits or refunds will be issued for non-participation or missed program days, due to weather, illness, or other voluntary or involuntary circumstance.
- 1.4 Seasonal program fees include the purchase of one (1) Transitionist Seasonal Program Jacket per applicant.
